## Application

**Shake before using. Ready to use product; do not dilute.**

On clean and dry surfaces apply MGT 23 K directly onto the surface and spread it out evenly with specific sponges or microfibers. Depending on the absorption and on the desired effect apply 2 or 3 coats at a distance of 4-6 hours one from another. If the surface is very rough apply with a low pressure gun and even with a long hair microfiber (See application accessories). We recommend to apply small quantities of product in more coats instead of one copious coat. The obtained result is not reversible. MGT 23 K can be applied on just washed surfaces, after thoroughly vacuuming the surface with a wet vacuum.

Wait until the surface is dry before walking on. Wait at least 48/72 hours before carrying out staining tests, so to allow the product to dry in the porosity of the surface. For the ordinary maintenance of the treated surface we recommend the regular use of MGP 24 detergent.

## Effect / Results

Laboratory tests demonstrate that MGT 23 K enhances the color more than other competing products and with fewer coats. The tests show that its resistance to staining agents is far superior to any other product of this category. **Coverage: Rough surfaces:** 1 litre for approx. 10- 12 m<sup>2</sup> depending on the finish of the surface and on its absorption.

**Honed surfaces:** 1 litre for approx. 17-20 m<sup>2</sup> depending on the finish of the surface and on its absorption.
