

CROCOSHINE

Professional, ecological polishing treatment with water repellent effect for polished natural or other surfaces.

CROCOSHINE is a protector which increases the shine of polished surfaces. Easy to be applied. It is neither a crystallizer nor a wax but a liquid treatment to be applied with a microfiber and polished with a white disc or steelwool. The maximum result with the minimum effort.

Suitable for: marble, granite, grit, Palladiana / Terrazzo, composites, agglomerates, some polished concrete, ceramic and porcelain stoneware.

On floors which have lost their shine CROCOSHINE may restore the polish without needing a micro-grinding. Can be applied after sealers.

Instructions

SHAKE BEFORE USING. READY TO USE PRODUCT, DO NOT DILUTE.

Apply CROCOSHINE directly onto the clean polished surface. Pour a small quantity onto the surface and spread it out evenly with a microfiber cloth or suitable tools with circular motions. (See application accessories). Do not use mops or clothes which could leave traces visible in backlighting. Do not exceed with the applied quantity, just apply a light layer.

Wait 20/30 minutes after application for drying. Once the product is dry the layer will become matt. Once it is matt the product can be polished with a cleaning or polishing machine using a white disc or if possible, steel wool. In case of manual application, the residue can also be polished manually with a dry cloth and circular motions.

On absorbing surfaces a second consecutive application may be necessary. In case of in backlighting visible traces polish carefully with steel wool. For the ordinary maintenance and cleaning of the treated surface we recommend the regular use of MGP 24 detergent.

Resistance

Internal tests and numerous applications carried out by our teams show that CROCOSHINE applied on polished surfaces offers excellent abrasion resistance compared to the classic metallic waxes to be reapplied periodically. CROCOSHINE also offers excellent resistance to water but should not be considered as an oil repellent. To get maximum protection we suggest applying MGT 27 K (Antistain water-based sealer for polished surfaces) or MGT 27 (Antistain solvent based sealer for polished surfaces) 24 hours before CROCOSHINE.
