Description

This hardener for outdoor / indoor surfaces and coverings represents the ideal solution for maintenance products and new buildings needing an excellent protection against abrasion, corrosion and chemical substances. It makes the following steps easier and offers a longterm protection.

Once hardened the protective covering COMPACT LTH creates a very hard and half polished coat, depending on the porosity of the surface and on the quantity applied. The treatment hardens quickly and does not turn yellow; it improves the aesthetical aspect and maintenance procedures, protecting the surfaces for a long time. Perfect for concrete floors, concrete blocks, ferrous/non-ferrous metals, aluminum, asphalt and existent coverings.

Owing to its adhesion properties COMPACT LTH does not exfoliate and offers an excellent conservation of the polish and of the color of concrete floors or other surfaces.

Instructions

Protect all areas that must not be treated with COMPACT LTH The surface must be clean, dry, free of any contaminating substance and in good conditions.

• APPLICATION BEFORE POLISHING OF THE CONCRETE SURFACE

Before grinding apply COMPACT LTH which penetrates into the open porosity of concrete. Spray the product onto the surface and spread out with circular motions using a microfiber cloth.

Allow to dry for 24 hours and follow up with the grinding steps until polishing the surface.

• APPLICATION ON CONCRETE SURFACES AFTER MINIMUM 7/14 DAYS

Spray the product onto the surface and uniform with circular motions using a microfiber cloth. Allow to dry the first coat.

Apply a second coat and distribute evenly on the surface with a soft bristle broom.

Allow every coat to dry before applying a further coat.

Allow to dry minimum 1 hour then apply a very thin coat of COMPACT LTH, using a microfiber buffer or an atomizer.

MODERATE PEDESTRIAN TRAFFIC AFTER 30 / 60 MINUTES, VEHICULES AFTER 2 HOURS.

To achieve optimum performance up to 24 days may be needed, depending on temperatures and humidity. Avoid standing water and eliminate immediately any kind of water or liquid traces or puddles.

Maintenance

Clean application tools and accessories with water.

Clean and wash the treated surfaces with cleaning machines and water. If needed use a neutral detergent like MGP 24.

DO NOT USE acid cleaners or solvents.

Packaging and Storage

Keep the original, sealed container in covered, ventilated, dry environment and keep away from heat or low temperatures. After the use keep the package well closed, so the product has a shelf life of approx. 36 months. Box of 15×1 liter bottle – Box of 4×5 liter cans
